- 4.1.5 To notify you about changes to our service.
- 4.2 If you are an existing customer, we will only contact you by electronic means (e-mail or SMS) with information about goods and services similar to those which were the subject of a previous sale to you.
- 4.3 If you are a new customer, we will contact you by electronic means only if you have requested us to do so.
